
A possibly greater battle with the elements approaches; the camp is being made water proof for the winter, log cabins and pathways under construction. Local support continues.

More actions are likely as Wessex Water plan to use the old Batheaston Reservoir as a dump for spoil from the construction of the bypass. TREE SITTING

At Blackwood Mill Near Darlington a group of Beech trees were threatened by the expansion of some private gardens. A request for an emergency tree preservation order was made but the council announced that it could not be considered until their next meeting. In the mean time 20 people camped out in the trees to help protect them. The police allowed them to stay there until the council, who in the end decided not to protect the trees, had made a decision. The tree houses were evicted during which three people were arrested. Although the threatened trees were lost, 29 other trees in the vicinity have had preservation orders placed on them as a result of the incident. On a brighter note, near Glastonbury a tree squat prevented the removal of a group of protected trees to make way for a private access road. Work was held up until the local authority stepped in to stop them being cut down. Direct action works!

WELLS RELIEF ROAD

Regular actions have been continuing against the Wells Relief road which will cut through the grounds of a local school. An en route squat has been evicted but another has been set up in a building whose garden lies in the proposed route. A tree in the path of the road has been saved through a decision to alter the proposed route after threatened actions. Meanwhile, the department of Health and Safety have confirmed that a building hastily demolished to make way for the road, contained asbestos. By occupying the proposed open cast site at Brynhenllys (S.Wales), direct action against Celtic Energy's part in the continuing rape of the valleys extends.

Funded by the local campaign, a network of walkways, nets and tree houses have been constructed. Farm buildings were barricaded and the first Welsh tower (alright, a small one) was built. This resulted in Celtic Energy 'bottling it' and leaving the protestors (mostly) alone, even as the proposed start of work came and went. Since then the amount of committed local involvement has grown. Work has been directed towards an open weekend to get more local's involved. The campaign will try and balance future activity between local crafters, squatting farm buildings and defensive work.

An Eviction will happen, despite some delay resulting from the local Plod insisting Celtic Energy hire private security guards (unlike Selar, where they did the jobs themselves). The land being squatted still has 500 acres of prime anthracite open cast. This is hundreds of millions of pounds worth of 'motivation' for a quick eviction.

SUNDANCERS UNDER ARMED SIEGE

In Shuswap territory in Canada a sacred sundance and burial site is being occupied by Native Americans. This land, and much of Canada has never been surrendered by treaty. As of August 27th all communication with the Shuswap camp has been cut and the Royal Canadian Mounted Police have surrounded the area with armed SWAT teams & helicopters. The sundancers have always maintained that they want a peaceful settlement to the dispute, but they have also stressed that they will defend the site to the point of being "removed in body bags".

Elsewhere in Canada, Mohawk warriors have seized a government building to protest about continued violations of the sovereignty of the indigenous peoples and in solidarity with the sundancers. At the time of writing they have barricaded themselves into the building, raised the Mohawk warrior flag and declared the building "closed for ever"!

One Canadian cop claimed "Brits don't give a shit about dancing prairie niggers". Prove him wrong, there are Canadian government buildings, tourist offices etc. near all of us ... act now! For more info contact 0181 749 7935.

RECLAIM THE STREETS

Not content with the massive Reclaim the Streets on the 23rd of July, RTS staged another action just over a week later. Arriving in rush hour at 7am 100 activists armed with 20 foot tripods blocked a major road passing through Greenwich. Up until this action most RTS/ Critical Mass's have been either at the weekend or when people have been travelling back from work. The action was successful and lasted all through rush hour. Five days later in Birmingham 150 pedestrians swarmed onto the street. Skips were placed across the road and while horns beeped, bands played and kids frolicked in the newly established beach and paddling pool. The action lasted for five hours and the organisers are planning another. Manchester are organising a Reclaim the Streets for October the 21st. Contact for further details 0161 248 9224.

OFFROADING IN SUSSEX

If we don't want cars on the road we sure as damn don't want them on the downs. With this in mind reACTION organised an action against the Sussex leg of the Eurochallenge Onyx Championship on August the 19th. 136, 4 wheel drive offroaders intent on ripping the downs to shreds were confronted by around 50 activists from Lewes & Brighton. Route flags were pulled out, the racetrack was invaded and a gate was blockaded. This stopped them accessing half of their track. Some drivers had come all the way from France, Holland, Belgium and Germany. A crowd shouting 'scum' at them on the finish line was not to their liking. With their racing ruined and half of the area due to be destroyed saved, they packed up.

EF! ROADSHOW

THE COMBINATION

"The Combination" is a group based in Norfolk in a rural location with just over half an acre of land, who are working towards a more self sufficient way of life. From this base they intend to co-ordinate an ongoing tour of Britain, a sort of 'no more roads-show'. It will also provide inreach into the 'radical environmental movement' with resource packs, coalition building, training and support. FREE TAHITI - NUKE CHIRAC!

As well as Greenpeace's actions, protests against French nuke testing are spreading around the world. In Tahiti protesters have invaded French Government buildings and are, at the time of writing, occupying and blocking the main road on the island. The protesters have been attacked by French riot police. Protests against Nuke testing have given the islanders' struggle for independance from French colonial rule a boost. Meanwhile 200 activists blockaded the main bridge across the Seine in Paris. Also a French airliner was hijacked halfway to Spain and taken to Switzerland.

M65

Direct action is continuing on the route of the M65, being led by an elderly local farmer whose farm is on the path of the road. He is refusing to obey the compulsory purchase order on his property, and has pledged to barricade himself in to one of the buildings when the time comes for eviction. actions occurring every day at 4.30pm, so get yourself down there. The farm is on Haslingden Road, Guide, Blackburn.

TARMAC-V-DOT

Tarmac and the Department of Transport are still "a million miles apart" from reaching a settlement over costs for the construction of the M3 through Twyford Down. The original tender was £26 million but eventually ended up at £44 million. Tarmac received £8.5 million for the delays caused by protests against the road but are still asking £28 million more for 'various costs' - including security costs.

THANET WAY

Despite the illegal eviction of their bunker site, the Flat Oak Society are continuing their protest against the A299 (Kent). They have moved to woodland site at Chesterfield and are regularly digger diving. A meeting to set up a local support group has occurred to counter the bad press and consequently the bad image they have received locally. On the 1st of September, 15 Police with dogs entered the woodland site at 3.30am obviously preparing for an immanent eviction. Papers have now been served. Tree houses, walkways & other defences have been built but people are needed to lock on, Contact 01227 275404 or mobile 0973 262259

STOP THE ARMS TRADE!

In a bizarre twist in the plot the people arrested where security guards. Realising the MoD were allowing protests to continue the security guards decided to kidnap some protesters and dump them in the middle of nowhere! SUING THE POLICE

A growing number of people are now suing the police for damages in court instead of making a complaint against the police. Two reasons for this are 1) If you are successful you get financial compensation (cash) and 2) people are realising that taking out a complaint against the police rarely succeeds.

If you have been a victim of police misconduct and want to know if you can take them to court, this leaflet will help you decide if you want to take the matter further, and what to do next.

Obviously your chances of succeeding in suing the police are better if you have witnesses supporting your claims and any other evidence to back up your case. It may be difficult to win if it is just your word against theirs.

WHAT CAN I SUE FOR?

Most people want to sue the police because they have been wrongly arrested, A black community activist accepted £50,000 and assaulted by the police or prosecuted for something they didn't do.

costs (believed to be around £70,000), to settle

Here are some things you should know about these types of action:

Wrongful Arrest

Unlawful arrest and detention is called false imprisonment The police must justify any arrest and detention, so if you think the police have acted outside their powers it is worthwhile seeking further advice. False imprisonment can happen on the street, in your home, in a police vehicle and of course at the police station - in fact any place where the police control your freedom.

Assault

This is much wider than many people think. You are assaulted as soon as someone touches you without a lawful reason to do so, and when they put you in fear of violence. Of course, it includes being punched and kicked and being subjected to illegal body searches. If you are assaulted by the police it is important to see a doctor (at casualty or your GP) straight away and for the injuries to be noted. You should also take photos of any injuries, if possible.

Prosecuted for something I didn't do.

This is called malicious prosecution. You have to prove that the police had no reasonable cause to prosecute you and that they had a "wrongful motive" in doing so. You also usually have to win your case, which means either (a) any charges were dropped before the case went to court, or (b) you accepted a bind-over at court before the case starts, or (c) you were acquitted (found innocent) in court

Other complaints.

You can also sue the police for negligence, trespass to land and goods, and a few other civil wrongs. It may also be possible to make a police complaint about some misconduct about which you cannot sue. However, don't make a police complaint if you intend to sue as this will provide them with your evidence before the case comes to court. It is highly unlikely that a police complaint will succeed. If you feel any of these apply to you, talk to a solicitor or advice or law centre.

WHAT KIND OF COURT CASE WILL IT BE?

Suing the police takes place in the normal civil courts such as the County Courts or High Courts. It is similar to other kinds of civil cases except that there can be a jury (as well as a judge) in cases for false imprisonment and malicious prosecution. You are suing the police for compensation for the wrongs done to you. It may, though, take two or three years for the matter to get to court. It is unlikely that any police officer will be punished as a result. For this to happen you would also have to take a complaint out against the police officer(s) through the Police Complaints Authority. Again speak to a solicitor, advice or law centre, before you do this.

HOW MUCH COULD I WIN?

It is very difficult to say because IF the case goes as far as the court, it is up to the jury to decide. However, in a large number of cases the police pay up before the case goes to court, as they realise they probably won't win. Either way, some awards can be for thousands of pounds (see boxes). In 1993/4 the Metropolitan Police have set aside £8.9 million to cover the cost of compensation payments and associated legal fees for alleged cases of misconduct by the police (Time Out - Issue 118 April/May 1993).

WHAT ARE THE COSTS OF SUING THE POLICE?

Legal Aid is normally available for these cases if you are not working, or on a very low income, or have high financial commitments. Legal Aid usually gives you an insurance against paying the legal costs of the police if you lose. Law Centres who do this kind of work may do so for free if you cannot get legal aid.

If you lose your case and are not legally aided you will probably have to pay your legal costs. These may be quite high so check this out before you start your case.

HOW LONG HAVE I GOT TO START A CASE?

Three years for assault resulting in personal injury, six years for everything else. But of course you should start as soon as possible.

WHAT SHOULD I DO NEXT?

You should write down the facts of the incident as soon as possible, including as much detail as you can about the police officers involved. You should see a doctor If you have any injuries. Speak to a firm of solicitors, but TRY to use ones who specialise in this type of work and are recommended to you. Campaign groups, Law Centres or Citizens Advice Bureaux should be able to help you with names of good solicitors, or at least tell you somebody who can.

CASE 1

A black community activist accepted £50,000 and costs (believed to be around £70,000), to settle his action, out of court, for false imprisonment, assault and battery and malicious prosecution, from the Metropolitan Police. It is one of the largest settlements and resulted from a police raid on a restaurant and community centre in Notting Hill, west London in May 1988. During the raid the man was kept face-down on the floor for twenty minutes with two policemen sitting on his back and another with his foot on his head.

CASE 2

In January 1989 a 73 year woman, was assaulted, maliciously prosecuted and falsely imprisoned by the police after her husband was arrested at their home in east London following a minor traffic accident. The woman was pulled to the ground and held down by three officers when she tried to give her husband his diabetes tablets. At the police station she was searched and charged with assault, but the charges were dropped. She sued the Metropolitan Police in a civil action and her award Included £20,000 for the assault, £15,000 for malicious prosecution and £20,000 for false imprisonment. Reported in the Guardian, Independent and Hackney Gazette Feb/Mar, 92.
