## IT'S JUST NOT CRICKET

### POTATOES ALL OUT FOR NOUGHT AS HEROES DIG IN

In Britain's first NVDA on a Genetically Manipulated-test site, the Super Heroes against Genetix First XI donned their outfits again for a game of cricket on a potato test field site just outside Cambridge this month. Due to the nature of a somewhat muddy and sticky wicket potatoes replaced the traditional red ball. Fielders had a difficult time of it - most of the batting resulted in the 'balls' being smashed to pieces or else being lost amongst upturned soil. The entire crop of the test site was destroyed.

Whilst similar actions have been ongoing in Europe for some time this is the first in a series on British sites and marks a further development in the campaign against GM produce.

A Super Heroes spokesperson, Captain Chromosome, said: "The Test Match proved a huge success if somewhat one-sided - we fielded a team of some thirty Super Heroes whilst the Cambridge team didn't even show up. It simply isn't cricket."

When contacted the Development Director at PBI (Plant Breeders Institute) in Cambridge was initially stumped by the scoreline claiming that he couldn't see how it was possible. On checking the site on Monday morning, Mr Killiam predictably denied that the destroyed potatoes had been Genetically Manipulated saying instead that they had been "normal".

The particular potatoes targetted contain an antibiotic resistance gene which is also contained in Ciba Geigy's (now Novartis) Bt maize. This does not

have the support of any country in the EU and is actively opposed by Austria, Luxembourg, Italy and France.

AND THERE'S MORE...

In the same week as the shennanigans in Cambridge German activists were also busy as a field planted with GM potatoes was destroyed. After the plants had been pulled out the field was covered with a 'white powder', which was rumoured to be a herbicide. This is not the first time that a field of Genetically Manipulated Organisms has been visited by anti-genetics activists in Germany. In 1996 at least 12 fields were destroyed and at present a further four fields are being occupied to prevent the planting of GMOs.

### AIRPORT EVICTIONS TAKE OFF

After a long hard winter in Devon and the rapid, violent evictions of Allercombe and Trollheim it looked like Babylon had caught up and many people predicted the end of onsite campaigning. Now it's all different: undersheriffs everywhere are wondering who's next; Surrey County Council couldn't afford to fight in Guilford; and Manchester Airport is counting the cost of another mammoth eviction. There the baddies made the same mistakes all over again with the security costometer spinning outta control. The vindication of tunnels and the press attention at Fairmile brought confidence, publicity, new people and energy to the campaign against a second runway at Manchester Airport. Underground

the much hyped "men in black" had their high tech operation reduced to hammer and chisels for most of the time and so are learning to appreciate how much work goes into defending the earth.

The eviction finally began in mid May at Zion Tree where tree dwellers led the first line of defence whilst the tunnellers held out for almost a week. Undersheriff Randall Hibbert managed to get his PR operation off to an appalling start as the first person out of the first tunnel in the eviction had been sprayed with what the bailiffs said was CS gas (though in reality it was water). To complete the blunder a journalist was truncheoned on the head when dragged from a bender despite making it clear that he was not going to resist. The media reaction to the violence set the agenda for the rest of the eviction - identifying the protesters as the 'good guys' although it's still difficult getting away from the lifestyle focus.

The fence constructed around the camps before the eviction meant that once the undersheriff appeared on the scene security levels were not necessarily stepped up though the several complete deconstructions of the fence, with security collaboration, was probably about the same cost. This cooperation meant that protesters were still able to gain access to the site even when the fence was up; many of the security were quite blatant about their support and acknowledged that they were 'doing a job' but no more. If this meant turning a blind eye to avoid confrontation then they were often prepared to do so. When the undersheriff foolishly banned the delivery of food and water to camps still awaiting eviction (a decision reversed after three hours in the face of protester and media outcry) the bailiffs pooled their lunches and delivered the food to one camp declaring that they disagreed with the dictat.

The eviction is now in its fourth week - the undersheriff having taken on one camp at a time and the tunnellers doing an excellent job at restricting the use of cherry pickers on site and ensuring that the eviction process lasted a significant time. Manchester Airport saw not only a strategic and effective use of underground burying but also a successful experiment with a 'scab-proof platform' on a treehouse. The four-storey construction, the Battlestar Galactica, managed to withstand four days of onslaught from the sheriff and his men and an increasingly infuriated Richard Turner and was eventually only defeated when a crane was brought on site.

What Newbury did for the south, Manchester Airport did for the north in terms of attracting thousands of new people and cementing the network for a sunny summer of actions. Aviation is firmly on the agenda and for more people than ever before it's clear that it ain't just about cars.

A new group, Arun Valley EF!, has started in Littlehampton, West Sussex. Their main concern is the proposed tourist developments in the Arun Valley above Arundel, one of the few remaining wild areas in the South East. AV EF! 01903 721615.

## AIRPORT SUPPORT

On the same morning that Undersheriff Randall Hibbert began an attempt to evict Flywood, the longest standing camp at the Manchester Airport protest site, his staff back in their elegant Chester offices must have thought they were far from the scene of the action.

Activists however didn't want them to miss out and took the protest straight back to Hibbert's offices. They managed to outwit two security guards, and gain entry to demand a meeting with the Undersheriff to discuss his refusal to allow independent legal observers access to the protest site. One activist locked onto a radiator, others inspected offices and made urgent phone calls and several more found their way onto the roof. Most of the staff seemed happy to have an early coffee break and a chat about the issues but two security guards (no doubt feeling a bit silly) kept wanting to try out armlocks on people and had to be scolded by police.

Eventually activists agreed to a chat by telephone instead of a meeting in person with Randy Hippy, as the Undersheriff has come to be known. He denied the need for legal observers, claiming that the eviction had been safe and gentle and refused to come to his office, claiming to be busy elsewhere.

Activists left after two hours, waving goodbye to the many police now occupying the garden. One person thinks she was arrested for breach of the peace - or maybe using the phone - but she's not sure...

## RECLAIM YER STREETS

They're everywhere, practically every weekend, and sometimes you can go along and not even know anyone. Outrageous. Even in York, where there was no sound system and the city is almost entirely pedestrianised, several hundred people turned up and danced all day in glorious RTS sunshine. Meanwhile the police, in a remarkable policy switch, voluntarily stepped aside and waved the Greenpeace solar generator van through. A week earlier in Sheffield over 1000 people reclaimed a city centre dual carriageway as a simultaneous Critical Mass bike ride cruised around reclaiming other streets in the vicinity. Whilst madly dancing the reclaimers allowed a nervous policeman to escort out an even more nervous jag driver whose precious guzzler had sat five feet from the sound system for over an hour but was left completely untouched by the anarchist hoardes. Struggling to reclaim the high ground the Sheffield local nonsense paper described the street party as "an aggressive hostile group allowed to hold people to ransom" and decided to focus on an old lady who couldn't catch her bus home.. Similar anarchic scenes have taken place in Leicester and Finland and, when Tony Blair heads off to Amsterdam for a change of scenery next week, he'll find more of the same madness there too.

## BAE ACTION

On June 2nd around 15 people occupied a British Aerospace office in Central London for four hours, 'liberating' the company's closely guarded ethical policy from their Manual of Corporate Governance and closing the office all afternoon. Some of the 15 included activists restrained by High Court injunctions from trespassing on BAe property. Unfortunately for them they forgot to list this particular site in the schedule of places covered by the injunction thus enabling the protesters to carry on resisting! 13 people have been enjoined by the courts for protesting against the sale of Hawks to Indonesia,

where they've been used to suppress East Timorese resistance to the Indonesian occupation. Help and advice in fighting injunctions particularly welcome. Phone BAe Injunctees Campaign (BIG) on 0161 834 0295.

## HOLTSFIELD II

The Holtsfield result in the House of Lords last month, in which some tenants won their case against eviction, was great as an initial victory but was limited as the developer, Elitestone Ltd, has served notices to quit on further tenants. Tim Jones will have to pay 50,000 court costs before eviction proceedings can go ahead, but there are three chalets from the last round of attempted evictions which can be repossessed any time and heavies have been seen at Elitestone looking at maps. A neighbour reports him saying "That lot won't know what's hit them this time!" Things might start happening soon so if you want to get on the phone tree call 01792 232643. The City and County of Swansea Council are seriously considering a Compulsory Purchase Order, but we can't pin our hopes on them - direct and urgent action is needed immediately.

## OIL BE DAMNED

The Department of Trade and Industry received a visit recently from a group calling themselves BP (standing for either Blairs Pals, Broken Promises, Bloody Politics) armed with a wooden cutout of Sir David Simon and an oil drill. The group soon struck sleaze (or was it oil? or was it brewers yeast?) on the steps of the DTI which resulted in a trail of sticky black footprints all over Whitehall leading from the DTI.

A large banner was then unfurled bearing the words 'New Labour New Sleaze' recalling the fact that within a week of taking office the unelected former Chair of BP, David Simon, had been elected minister for competitiveness in Europe. BP in Columbia has admitted to paying the army and is accused of passing intelligence about protestors to paramilitary death squads. Hundreds of trade unionists and environmentalists have been killed.

Closer to our fair isle BP is facing criticism from Shetland fishermen who have been blockading Sullom Voe with around 15 boats. The terminal is run by BP on behalf of a consortium of oil companies and the fishermen are angry that they are not getting compensation claims for the Braer disaster.

## AYE AYE CAPTAIN

At the end of May Paul Watson, the Sea Shepherd Captain jailed in Holland, won the first round in his battle against extradition to Norway when the presiding judge threw out two of the most serious charges. He will now spend two weeks considering the remaining arguments. Paul was detained in Holland in April following a Sea Shepherd action against illegal Norwegian whaling. The Norwegian state laid their charges and demanded extradition but with 'wreckless navigating' and 'illegal entry into Norwegian Waters' out of the way the case has become a little flimsy leaving only the minor charge of sending a false distress signal. For this heinous crime Norwegian navy commandoes dropped four depth charges on Sea Shepherd, fired on her with 50mm cannon and sheared off the bow in a ramming attack. The legal team relish the PR opportunity of this going to court and by the time of the ruling Paul will have been in jail for over 60 days even though sending a false distress signal normally carries just a small fine.

The initial verdict means that the Norwegian government has been rebuffed for sending an unjust extradition order and it is another Direct Action victory for everyone opposed to whale slaughter. But there's

## PRESSMENNAN EIGHT

Eight people have been arrested near Pressmennan Wood in East Lothian and charged under an 1865 Act which was passed to stop dispossessed crofters occupying their crofts during the Highland clearances. These arrests took place at the camp set up in protest at plans to fell ancient oak trees at Pressmennan.

Pressmennan Wood north contains over 1000 mature oak trees which are at least 200 years old. Plans are afoot however to fell 360 trees for sale to a timber company.

Since the original camp was evicted in mid April another camp has been set up in the adjacent Meiklerig woodland. As well as the oak trees the area targeted for felling also includes majestic beeches and ancient Caledonian pine. ## SHOREHAM

On 16th May this year we attempted to 'combine the issues, confront industry'. By inviting the relevant malcontented single issue groups like anti-timber and animal rights to stand together and "shut down the port". Come the morning there were 60 of us and 800 of them. The police were anticipating an animal rights demo, and it was reported that 9 AR houses were raided over Shoreham, spreading hopeless paranoia. Realising we were not quite ready to take on modern civilisation in its entirety that day, we considered our options then sat in the sunshine with ice-cream and coffees. What followed was 25 people split into groups of 5 entering Marks & Spencers at 3 minute intervals. A trolley run of all soya foods held up every till while a "you are all in danger" rant serenaded the shoppers. The unimpressed managers called for back-up which came in the shape of 6 cop vans from Shoreham. We even had the very first arrest for a genetics action, for criminal damage to a shirt!

## YOU'LL NEVER STOP IT YOU KNOW

You won't need much analytical skill to work out the victory at Stringers Common where Surrey County Council have completely backed down and abandoned their plans to widen the A320. They faced a protracted battle in the trees and tunnels of five camps on the site and decided that it just wasn't worth it. This saves them quite a bit of cash but more importantly the determination and commitment of the Direct Action movement in this case has saved an SSSI, a pond and 221 mature trees all held together in an established eco-system. Part of the success has to go to the growing acceptance that people are right to fight for real progress and that it's not something which is going to go away. One of the campaigners at Stringers Common said, "the public are waking up to the realisation that more roads can only be bad news for the environment and our health. This is a victory not only for the local people around Stringer's Common but for everyone that has dared to stand up to car culture, from Twyford Down, to the M11 through to Newbury and the proposed Bingley Bypass. If the camps had not been here this road would have gone ahead. The cost of evictions has made it impossible and direct action has again proved to be a successful tactic in defending our environment." As soon as the Compulsory Purchase Orders have been cancelled the camps will be dismantled and the land restored to how it was before the activists arrived leaving the common safe for future generations of people and wildlife.

## GET DOWN TO LYMINGE

The Stringers Common spirit should be attracting hoards of pixies to Lyminge Forest where another ridiculously possible victory is waiting to be won. The Forestry Commission have been 'obliged' to sell 440 acres of forest to Rank Organisation for their planned holiday village but the planning permission states that the land must be vacant before the sale can even go ahead. Although possession orders have been granted, like at Guilford, the more difficult and expensive evictions look then the more likely it'll be that they just won't happen. There's lots of speculation about when so the call is out now for people who want to work. Other attractions are the site's proximity to the coast, the upcoming fruit picking season in the 'Garden of England and the totally tatted Forestry Commission's log cabin toilets.

## PROTEST CAMP AT WYNDHAM HILL

Wyndham Hill, in Yeovil, is bordered on three out of four sides by concrete, development and car parks. It is a precious fragment of natural habitat, topped by 4 old lime trees. On the open part of the hill is an unbroken view of the Dorset border, marked by the river Yeo. Nestling into the hill is a popular river walk used by thousands. Now all of this is threatened by 'development'.

There have been plans to develop the hill in the past. In 1994 Sainsbury's plans to build a store on the site were scuppered. They also intended to fund a 'bypass' that would have destroyed the riverside walk and conveniently acted as an access road for them. Using a combination of lobbying and direct action Sainsbury's were well and truly persuaded to give up!

This year South Somerset District Council produced a draft plan, showing that they intended to trash the hill by building a carpark and link road on it. Now they have seven tree houses with more on the way and underground tunnels to contend with. The tunnels go under an existing car park which the council has had to close through fear of subsidence - it will soon be used for more useful things, like growing cabbages and beans!

The main camp has been in place for over two months. It's on the edge of a 16th century country estate which will also be trashed if the "Evil Lords of Tarmac" get their way. There are about thirty residents at present and they've had massive local support (a "Beep for Wyndham" sign has had to be taken down because the beeping was continuous!). Eviction orders have been given, a court case held and they've been ordered to leave forthwith. Activists believe that this is a winnable campaign so are encouraging people to join them as soon as possible. Contact 01935 863349 for info.

## TROLLERCOMBE MILE

A collective of A30 campaigners tested the 'Vote Labour for more of the same bollocks' idea by setting up a new camp on the lunar landscape which was Fairmile. As site security dreamed of winning the lottery, locals and activists dug through the night and by morning had a secure section of tunnel, erected a tripod and recycled lock-ons which had been left on site since the eviction in January. Finally security got on to it and whole place was soon swarming with police and media, all suitably stunned by the crafty ingenuity. A30 Action challenged New Labour to halt all DFBO schemes and demanded a public enquiry into the A30 works (there's never been one). It took most of the day for police and security to clear the site and by the evening New Britain was much the same as Old Britain (except for a bigger and more expensive security presence).

The Peaks Parkway project is a planned 5km diversion of the A16 through Grimsby. For much of its course the road will follow the line of the old Grimsby-Louth railway. Several groups have formed to oppose the building of this road on various grounds: the road is routed along an important section of green belt and recreational space, it will take in part of the site of an Iron Age village, it will divide two schools from their catchment areas and it will run through a densely populated residential area causing the compulsory purchase of homes and gardens. Traffic patterns around Grimsby have changed dramatically since the road was first proposed over 20 years ago and the planned development is now being described as obsolete, before it is even built.

Over the last few weeks local residents have initiated peaceful protests on the site, including holding parties and jumping in and out of the contractor, Birse's, compound. Protestors have also marched through the city centre bearing a coffin containing a tree. To date campaigners have had 9 arrests for obstruction and aggravated trespass and 3 school children have been charged with a criminal offence for trying to stop the destruction of trees, hedgerows and wildlife. Help is needed - camping space is available and about 20 of the housees on route are lying empty. All are welcome to the campaigners' Solstice Party. ## BEAGLES IN CONSORT

Beagle breeders in Consort, Hereford have watched monthly actions on their kennels grow to national closedown proportions. The latest in May saw the police lines overrun and a couple of hundred liberators pouring into kennels. Surprised cops resorted to CS gas but were still powerless in the face of mass action which so far has used up half of their budget.

There's up to 800 beagles at any time in Consort where thousands are bred and sold to vivisection labs every year. Channel Four's "Countryside Watch" has shown the puppies being punched, injected, thrown around and then killed and gutted at just six months old, and all this for profit. Outrage at these scenes have brought thousands to Consort over the past few months with the next action on 6th July promising to be the biggest ever.

Consort is just 5miles up the A49 from Ross-on-Wye. Meet at 12.00 noon at the main gate. Info call 0171 278 3068

# CS GAS

## ITS EFFECTS AND HOW TO COMBAT THEM.

In the last few months the police have used CS gas on activists and demonstrators several times; twice at Consort, the vivisection beagle breeders in Herefordshire, and more recently at a post-action party in Kent. There's even unconfirmed rumours that it was used by eviction teams at Manchester airport.

There's already been a couple of police custody CS related deaths so these examples of its use at actions should be taken seriously. CS is an accepted part of the police arsenal and we are likely to see an increase of its use at demonstrations. Everyone should be aware of this worrying trend and be prepared to deal with it.

### BRIEF HISTORY

CS is short for O-chlorobenzylidene malononitrile. The properties of this compound were first discovered by American chemists in 1928, and the potential chemical warfare uses suggested by a Dutch writer a little later in 1934. During World War Two scientists in various countries studied the compound but it wasn't seriously developed as a weapon until the mid 50's. The first widespread use was during the Vietnam War, both in America and Vietnam, and it has remained a favourite of police forces and armies ever since.

Police in the UK have had access to CS for years and have used it often in Ireland. But now it has passed from specialist riot control units and is on general issue to forces throughout the mainland. It's carried in small cans the size of roll-on deodorants and attached to the standard copper's belt. (The large green canisters you can see on belts of riot police are not CS but fire extinguishers).

### THE EFFECTS

The canisters currently carried by the police contain three ingredients; the active chemical (CS), a liquid solvent to dissolve and carry it and an inert gas to act as a propellant for the spray. The active ingredient CS is one of a group of chemical compounds called lachrymators. These chemicals are tear producing agents, hence the euphemism 'tear gas'. Exposure causes severe eye irritation, a profuse flow of tears, skin irritation (especially on moist areas of the body) and irritation of the upper respiratory tract, causing sneezing, coughing and difficulty in breathing.

### WHAT TO DO WHEN SPRAYED

(1) If you are in the line of spray move away or if in a building move outside. Your eyesight will become very blurred and you may lose awareness of what is going on around you. Do not run blindly away as there is a real danger of running into the arms of the police or traffic. Try to act calmly and stay aware of your surroundings while moving to a safe area.

(2) Stand upwind of where the spraying took place and expose the affected part of your body to the wind. This will help disperse the gas.

(3) Flush the affected area with cold water. Do not rub or itch as you will spread the chemical and rub it into your pores. Depending on how much gas you were sprayed with it may be possible to return to the action as small amounts should only effect you for a few minutes.

(4) When possible have a cold/lukewarm shower (hot water opens the pores letting in gas particles). Showers flush particles away while baths may spread them around.

(5) Later you should hang your clothes in a well ventilated area to disperse the last particles. When they've hung for a day or so wash them twice, once in cold water, then again in hot and they'll be okay to wear again.

CS Gas is fat and oil soluble, so never coat your face in petroleum jelly or similar substances for protection, as some people tried in the Anti-Vietnam War protests of the 60's. Don't treat the affected area with any cream, jelly or ointment unless advised by a doctor; this will spread the chemical and aggravate the symptoms. The best treatments are air, cold water and time.

### PROTECTION

(1) The obvious one is a gas mask. They're available but expensive (the only ones worth using are current ex-military designs). They tend to be bulky and make you conspicuous in a crowd although in the future they may become standard wear for everyone.

(2) A mask and hood will offer some limited protection and they are well worth wearing anyway for disguise. An improvement on the normal bandanna is a special cycle mask (the Respro Urban Bandit is particularly good - about £10 from your local bike shop) as they contain activated charcoal which filters out CS.

(3) Goggles can be useful for eye protection and are easy to get hold of and carry.

(4) Carry a bottle of clean water to rinse the skin and eyes of anyone sprayed.

(5) If you're asthmatic tell the people around you before the action or demonstration starts so that if you have a bad reaction they'll know why and be able to react appropriately.

This may seem over cautious but to be forewarned is to be forearmed. Here's hoping you never need it.
