

## ACTIONS AT ALDERMASTON

This weekend saw further evidence of the re-emergence of the anti-nuclear movement in Britain, as Trident Ploughshares 2000 activists from around the South-East, took part in protests against the manufacture of nuclear weapons at Aldermaston.

In the evening of Saturday March 20th two people scaled the perimeter fence, hanging banners from the barbed wire and decorating the fence posts, before being escorted out by MOD police. Others planted rows of sunflower seeds alongside the fence. Sunflowers absorb radiation, lessening the impact of contamination from the base to the local environment.

On Sunday morning protesters gathered outside the main entrance, blocking the entry of traffic to the base. They and MOD police were kept entertained by the first performance of the anti-nuclear play 'Monster'

## START 'EM YOUNG!

Kids and parents of Chevassut primary school in Hulme, Manchester, have taken to direct action after a Secretary of State decision to close the school was made on Tuesday 16th March. The following morning, pupils, teachers and parents jointly blocked the road past the school for an hour before school started. The same action had taken place the Monday before, this time including a tripod and other local residents. Police were present but their instructions to clear the road were ignored. Subsequently it was decided by those involved to continue with the early morning blockades until the future of the

## 121 CENTRE UPDATE

The 121 centre is still there after 18 years of squatting and almost 60 days of having been barricaded to resist the imminent eviction. Parties, a weekly cafe, meetings and video nights are still held. Action has been taken outside the centre with an occupation of the office of the head of Lambeth Council, a cafe on the High Street and a public Drink-In in defiance of a newly imposed ban on drinking in public for Brixton.

On April 10th at 2pm the action will be stepped up further with a Brixton Street Party for which many hands are needed in preparation and on the day.

## DTI OCCUPIED

On Wednesday 3rd March activists from the Simon Jones Memorial Campaign held two protests in London. Simon was a casual worker who was killed on his first day of work at Shoreham Docks, having been forced off the dole and in to casual work.

The first protest was staged outside the House of Commons to coincide with the debate on casualisation. People then made their way to the Department of Trade and Industry where they occupied its entrance lobby, demanding that Personnel Selection, the recruitment agency that 'found' Simon the job, be prosecuted for his death. The entrance was blocked for an hour while employees enjoyed an extended lunch break and hundreds of leaflets were distributed to employees and passers by, many of whom expressed support for the campaign.

Simon's death highlights the spread of low-pay and casualisation across Britain; as a spokesperson from the campaign said: "If you want to kill someone, the easiest way to get away with it is to do it at work."

## OI - NO!

Quarry operators Pioneer Aggregates have begun blasting work to extend the quarry at Ashton Court into adjacent meadowland. A protest camp was set up last year to resist this and after months of activity it has now been taken down. It did not, however, go without a noisy exit.

A week of action took place in early March. To kick it off, protesters visited Ian Wattle, Pioneer's planning manager, and translocated his lawn on to the pavement outside his house. The daffodils from his garden were planted in his car.

Later on in the week, two people abseiled 100 feet down onto a ledge in the quarry five minutes before the face was due to be blasted. They proceeded to pitch a tent, put up an official squatting notice, erect a dry stone wall and unfurl a banner reading 'OI-NO!' Climbers had to fly in from Dublin to remove the protesters before blasting could continue.

## CRYSTAL PALACE SITE EVICTED

The protest camp at Crystal Palace has been evicted at a cost of over 1 million pounds. The camp was set up in April of last year to resist the planned 18 screen multiplex development on park land in South London.

On the 3rd March, bailiffs, accompanied by around 350 police, moved on to the site and began removing the 50 people present from the various tree and bunker defences. The eviction was completed a record breaking 19 days later when the last two occupants of the site voluntarily came out of the bunker they had been in since the beginning of the eviction. They chose to come out because the bailiffs had almost got through to them anyway and they had run out of food and water.

All those who were on site when the bailiffs came were arrested. 30 were charged with obstructing an officer of the court, two with assaulting an officer and one with affray. One man was remanded, due in court on March 30th, charged with obstructing an officer of the court and breach of bail. One resident of the site, Animal, was remanded in custody, see prisoners section.

Meanwhile, on the 20<sup>th</sup> a solidarity action was staged at the Universal Cinemas International cinema in Leicester Square. Four people with placards climbed up on the roof and took down the union jack which was flying there while a crowd, estimated by police to number around 900, gathered on the ground below.

## WOMEN WALK FREE

Two women, charged with £605,000 worth of criminal damage, appeared at Plymouth Crown Court on Monday 29th March to hear that all charges against them had been dropped. The three hundred supporters who gathered in the rain outside the court were kept entertained by music and street theatre. A flag, bearing a crossed scythe and spade over a biohazard symbol, was flown from the court's flag pole.

The women faced up to ten years in prison for 'conspiracy to cause criminal damage' after taking part in the destruction of a crop of genetically modified maize on 3rd August 1998 from a test site near Totnes in Devon.

After seven months of severe bail conditions, which included a 10pm curfew, the defendant's lawyers received a highly unusual one-line letter saying that "for complex reasons the Crown intend to offer no evidence in the above case." The Director of Public Prosecutions himself appears to have felt that the planned defence of 'lawful excuse' would have stood up, creating an unwanted precedent. There was certainly no lack of evidence against the two women as both have always admitted damaging the maize.

One of the women commented: 'this decision shows that we were right to stand up to the bullying of the biotech companies. I hope this encourages other communities to take action to protect our environment.'

Prior to the planting of the crop, six hundred local people had marched to the test site in protest. When this failed to persuade the government to halt the trial, the crop was removed by about 20 people. Ten others were also arrested on the day but it now seems unlikely that any of their cases will come to court. In the weeks after the arrests, 3000 local people signed a statement saying that they felt that the action taken to remove the maize was in the public interest

## MANCHESTER SQUAT CAFE

The OKasional cafe is back in Manchester for the fourth time, to celebrate it's first birthday. The cafe collective has re-squatted the building in which the cafe made its first appearance. The Grade II listed building is located opposite the university, smack bang in the heart of Manchester's student 'ghetto'. Since it was last occupied, the owner had simply boarded it up, half heartedly cut off the electricity and water, and left it to stand empty. He was said to be not amused to see the building he wants to sell re-squatted, especially by the same people he'd previously introduced to the courts and Under Sheriff.

So far, the cafe has been home to big free parties, dozens of workshops, discussion evenings, meetings and direct action film all-nighters. It serves vegan, mostly organic fair-trade food on a donations basis, with any money raised going into environmental and social campaigns.

The squatters decided not to enter into negotiation with the state or the mainstream media, as 'it's a space we're collectively creating, and will defend for as long as we want.' One of the collective is quoted as saying: 'The owner has not so far issued court proceedings, and when the local Tactical Support Group (riot police) turned up, we showed them the door.'



◆ Anarchists and EF!ers in the Czech Republic are appealing for help to defend themselves against a fascist attack on May 1st. This date has in Prague, as in many other places, been a day of anarchist activity for many years but this year fascists from all over Europe are planning to stop it, threatening to burn all anarchist squats and rid the Czech Republic of anarchism. ◆ March 11th. A genetically modified potato crop in New Zealand was destroyed by a group called Wild Greens. The research project, worth \$200,000 was ruined. Sadly the activists discarded gloves and clothes at the scene and DNA samples were taken. Greenpeace NZ put out a media release condemning the attack. ## STOP THE NEW DEAL! REED TARGETED

On 8th March, a coalition of workers, students and the unemployed, otherwise known as Leeds EF! and friends, visited the Leeds office of Reed Employment, the company which is administering the New Deal Gateway Centre in Hackney.

Ten people entered the offices, while a further ten remained outside with a banner and leaflets. There were around double this number of staff in the building, which made any serious disruption difficult. Some staff were prevented from working however, and the police were called. Eventually it was agreed to leave, in exchange for a phone call with Reed's head office, letting them know that the action had taken place.

The media was not contacted about the action, instead the group decided to put some effort into creating their own publicity: Dole offices were leafleted afterwards, and, the following day, a report of the action, together with information on other campaigns, was flyposted around the city.

Some people, while visiting council offices later in the day, climbed the columns of the offices and cut down their New Deal banner, nicely rounding off the day's events.

## SUPERMARKET ACTIONS

On Thursday March 4th, activists removed genetically modified products from the shelves at a Sainsbury's store in Cardiff, to 'inform the public of the risks that GM foods pose to human health, the environment and the developing world.' Stores in Aberystwyth, Bangor and Swansea were also targeted with a variety of protests.

On the 6th of March 150 people staged a protest at Safeway's store in Totnes. The manager was presented with the results of a survey showing that over 70% of customers wanted Safeway to go GE-free. A banner was displayed which read "GMO-Free - the only safe way". Similar actions have also taken place recently in Plymouth, Bodmin, Newcastle, Worcester, Warminster and Taunton.

On March 29th, genetiX snowball activists delivered 50 items of genetically modified food to the Ministry of Agriculture Fisheries and Food, declaring it to be a biohazard. The food items had been 'confiscated' from a Tesco's supermarket the Saturday before. Attempts to take more items from Safeways were stopped by police. One woman was arrested for stealing the food. ## STOP THE CROP

On March 28th a protest was held at a genetics test site near Edinburgh. The action was called by Fife Earth First! and took place a year to the day after 60 people openly pulled up a crop of genetically modified oil seed rape near Fife.

This time round the protest consisted of over 100 people who, after listening to a couple of speeches, proceeded to march to the field. Fifty police, with horses and dogs, had got there in advance, but 12 people managed to climb the perimeter fence and began pulling up the plants within. About one third of the crop was trashed, possibly invalidating the experiment.

Six people were arrested and charged with vandalism, one was also charged with theft of plant

## DOING IT IN THE NORTH GOES TO LIVERPOOL

On March 11th, about 60 folks arrived in Liverpool for the third 'Doin' It In The North' action, with the intention of getting in the way of the genetix industry just a bit more.

A small group went to leaflet supermarkets in Liverpool city centre while most people went to Cargill's Docks where genetically engineered maize and soya is imported. Unfortunately, the police arrived on the scene simultaneously and the gates to the docks were shut before anyone managed to gain entry. A scuffle with police and security guards broke out as people tried to get over the gates. Some people did manage to get through when an undercover person on the inside found the gate control button, and two briefly gained entrance to the offices. All in all seven people were arrested and charged with Disorderly Behaviour.

At this point it became obvious that the docks and offices were not going to be occupied. However, the gates to the tanker loading bay were successfully blockaded for nearly 2 hours, temporarily halting the collection of the GE maize and soya oil that is processed at the docks. Discussions of the issue with Cargill workers also took place.

At a pre-arranged time participants headed back for the de-brief and evening socialising that are an important part of the DIITN actions. One of the most positive aspects was the inspiring and strengthening effect the days action had on the Liverpool group.

## FELLING STOPPED

On the 27th of March, Manchester Airport began felling trees in Moss wood, but were stopped by residents of the camp in near by Arthurs Wood. A new camp was then set up to guard against future felling,

The trees in question will prevent the use of radar for the airport's second runway if left to stand.

A vegan camp has also been set up, and the first camp, which has been involved in legal proceedings to try to maintain possession, is now safe from eviction until August when their case goes to the house of Lords.

## AGRO-CHEMICAL ACTION

On March 22nd, 10 people breached the perimeter of the Rhone Poulenc factory in Norfolk, and were almost immediately arrested on suspicion of criminal damage to the perimeter fence. Twelve people outside displayed a banner reading 'Hazard' and gave out leaflets to workers and passers by.

The factory is mainly concerned with the production of agro-chemicals, including the world's supply of bromoxynil, a chemical which is so toxic that it is illegal to use it the EU and the USA, but which is exported for use in the third world.

Rhone Poulenc is a French based multinational which is also heavily involved in genetic engineering. One of its subsidiary companies is involved in genetically engineering cotton to be

## BULLDOZERS BANISHED AT TOYTOWN

The camp at Toytown, set up to defend one of Cheltenham's local green spaces from a Waitrose supermarket, closed down a few months ago but the campaign continues.

Direct action is sometimes surprisingly little effort. On learning that the council were coming to level the site, five people came down to try and stop work. They climbed on the bulldozers and said to the drivers "Go away and take your machinery with you". And to everyone's surprise they did!

As far as the campaign knows, there are no immediate plans for the bulldozers to reappear, but if and when they do, people will take the same action again.

## COMMUNITY TAKES OVER FROM CHURCH

The Community Centre on Gloucester Rd in Bishopton, Bristol, has been occupied by its local users for several weeks now, after the Church of England, original owner of the premises, decided to replace it with a church. This despite the fact that there are 6 other churches in the area already and none of them are exactly packed out every Sunday.

The residents of Bishopton are keeping up daily events catering for deprived people and offer the space to everybody for meetings and other activities. They have taken their struggle to London, with people chaining themselves to gates outside Lambeth Palace, and pressing the Archbishop of Canterbury to intervene. Help with the running of the centre is always welcome, as well as legal advice and donations. The case for possession of the centre will be in Bristol Crown Court 10am on April 19th - be there to show your support and put the pressure on. You can also go and tell the Planning Dept in the City Council what you think of them for giving consent to the change of use of the buildings.

## STUDENT OCCUPATIONS

Earlier this month, over 200 students at Goldsmith's College, London, occupied the university's administrative centre in response to the recent expulsion of eight students unable to pay their tuition fees.

The action had the backing of the student union. Lectures were allowed to continue as planned and students to continue their work in the building.

The occupiers built barricades and demanded the reinstatement of all expelled students, no further expulsions due to inability to pay fees, notification of the student union of any students not paying fees, the college to call on the government to increase funding for higher education and immunity for all students involved in the occupation. Seven days later they walked out, all of their demands having been met!

This protest is one of many across the country in response to the assault on working students and free education. Occupations have also happened at Camberwell, where some demands were met, Guildhall, where all of them were met, and University College London where the occupiers were removed by police. Many of these campaigns have pointed out the parallels between New Labour's attacks on students and their other oppressive policies, including racist

## ROAD RAGE IN ROSLIN VALLEY

For over a year the Non Alignment Action Group (NAAG) have been opposing plans by Midlothian Council to have a £20 million, privately financed road built through Roslin Valley, South of Edinburgh. The planned road would damage an SSSI and effectively destroy a part of Edinburgh's greenbelt.

While the Council has been reluctant to start a public enquiry, campaigners are keeping the pressure on with monthly walks of the planned route. The next such walk is planned for the 4th of April.

Some research farms have several test field sites for non-GM plants as well as several GM deliberate release sites, this makes identifying and inspecting deliberate release sites problematic. Most of the sites on this sheet have a grid reference but this often refers to a building rather than the crop. Therefore you have to have an idea of what a test site actually looks like because it is obviously important that you get the right site. Many farms are experimental farms and therefore have lots of test sites, not all of which are GE.

# OFFICE OCCUPATIONS

Corporate decision-makers sit in cosy offices far removed from the consequences of the decisions that they make. Occupying their offices can be an effective form of direct action, especially for a relatively small group of activists.

Before you get to the target office, agree on the aim. Is it to simply make your presence felt, to gather information or designed for maximum disruption? Everyone should agree on what to do inside, and how long to stay for - and stick to it.

**Reconnaissance** is important. Look for ways in, such as open ground floor windows, fire escapes, and side doors, and ensure everyone knows the basic layout.

**The best way in** is usually the front door! Anyone who doesn't want to go in could picket the entrance, and leaflet cars in the workers' car park. Make a simple plan to get in. Entrances often have security locks, swipe-card readers, or intercoms. One smartly dressed person going in and opening doors and windows for everyone else often works. It helps if this person has an excuse such as courier delivery, an employment inquiry or a pre-booked appointment with a named worker. This person must be prepared to react quickly and sometimes decisively, for example, to push past employees to get doors open when the rabble arrive. If the only door is a revolving one then windows will be a better bet. Alternatively, you can sneak in behind employees going in, or catch the door as one leaves. Ensure that you aren't spotted beforehand.

**Once in, the fun starts!** You might all look for specific offices or scatter through the building to cause chaos, but stay in pairs at least, as office workers can defend their space assertively. In the past it has often worked for groups to barricade themselves into unoccupied offices thus ensuring an uninterrupted search / reorganisation. In open plan offices, or when barricading options are limited, there is a tendency for activists to drift to one place after the initial rush. Try to avoid this as it makes it easier for staff / police to contain you and get you out. Keep it calm and non-confrontational, especially as most workers you come across will not be the decision makers; seek out the bosses! Reassure workers who seem frightened by your invasion that you intend no violence, and distribute leaflets explaining your case to them.

**If your goal is disruption**, rearrange paper and filing cabinets, lock doors and hide keys, unplug things, barricade yourself into empty offices, play with computers (see facing page). Keep it tidy, and they might not discover what you've been up to until later;

obvious criminal damage or theft on these type of actions may lead to everyone being arrested especially if you are few in number. That said, some occupations have involved smashing up as much as possible.

**If your goal is info-gathering**, get in and out quickly, there is nothing to be gained and a lot to be lost by hanging around because a 30 minute action seems too short. Rummage through filing cabinets, go through desk diaries, look at notice boards, search through computers and photograph or photocopy anything interesting. Alternatively, you could fax documents to someone on the outside, who should be briefed to keep their fax line free. You may want to borrow some documents or computer disks to study at your leisure... chuck them out of a window to waiting colleagues who can spirit them away immediately. Don't hang around waiting to be arrested. Leave a pre-printed disclaimer in their place, stating that anything removed will be returned undamaged within 24 hours. This gives time to read files and copy useful stuff. You can return the files either to the office doorstep in the middle of the night, or (anonymously) to a police station lost property office in a different town. It is essential to return everything if any one does get nicked for theft; although the disclaimer has no actual legal weight, charges should be dropped if files are returned as promised.

**Everyone should leave together**, and make sure no one is left inside. Be aware that police often search everyone before they leave the office, especially if anything appears to have been removed or damaged.

Office occupations generally don't lead to arrest. However, there is the **possibility of arrest**, most likely for breach of the peace, burglary or section 241 of the Trade Unions Act 1994. Burglary is often used as an excuse to arrest. Don't openly eat food or use electrical equipment or they may indiscriminately make arrests. Most arrests will not lead to a court case. People have sometimes gone in with a list of demands such as a meeting senior management. These demands are generally not worth winning and negotiation for them may make a court conviction more likely. This happened to the 20 'Opencast defendants' in 1998, when it was taken as evidence of coercion, to secure a conviction for section 241. This case was exceptional however as £350 000 worth of damage had been done to a nearby mine earlier in the

# Fun with Computers on office occupations

If before going in to your office you spend a bit of time familiarising yourself with some of the ideas and procedures below you could do quite a bit of 'not immediately noticeable' damage and may even end up with a 'gateway' into their

While some of your mates are going through the desk diary, the filing cabinets and the drawers it may be worth you taking a look at the beige box with a telly on it in the corner of the desk.

Before you decide what best action to take you have to have a browse around the PC. If the computer is off, switch it on. The computer may appear to end its starting procedure with a logon box. Many systems save the username of the last person to use the computer in this box, write this name down, if the user has e-mail it can probably be worked out using this username@whatever.co.uk (alternatively find the persons calling card). E-mail addresses are handy to have as viruses and hacking tools can be sent to the unwitting user at a later date. You may try a couple of passwords (look for obscure things written on post-it notes) This probably won't work and after a few tries it will tell you that you are locked out of the network. Just accept this and click cancel until the computer seems to be running.

If the computer is already on then open the Windows Explorer and check out how many drives there are. If there are more than 4 drives then you are probably already attached to the network.

The following assumes that Windows 95 or 98 is installed but probably applies to Windows NT too.

**Re-formatting** This is quite un-subtle and may cause the least damage of all. In any fair sized company most data will be either stored on a file server or backed up nightly. Having said that most users are crap at doing this (especially those at the top of organisations). If there appears to be no network attachment then this may well be your best option. To format the disk select *Start menu - shutdown - restart computer in MSdos mode*. When you get the C:\> Prompt type **format c: /u**

**Repartitioning.** If you're going to re-format a hard disk then you may as well repartition it too. Repartitioning a drive just makes it a bit harder to recover any data than a simple format. Get to the C:\> prompt. stick a floppy disk in and type **sys a:** then type **copy c:\windows\command\fdisk.\* a:** if no file is found then type **copy c:\dos\fdisk.\* a:**. Then format as above. Reboot the PC with the floppy disk in the machine. Type **fdisk**. Then delete all partitions, reboot again type **fdisk** again and create 2 or 3 new partitions.

**Delete files.** Deleting files on the hard disk in the machine is pretty simple. Highlight the files you want to delete. Select lots by holding the *Shift* or *control* key down as you click (experiment with this). Before you press the *delete* key hold down the *shift* Key. Do not release the *shift* key until the *confirm file delete* box comes up. If you don't hold *shift* down the files will only go to the recycle bin. After deleting you may as well empty the recycle bin. Click on the recycle bin and choose *empty recycle bin* from the *file* menu. To make absolutely sure that the data can't be recovered install a Disk cleanup utility ([www.execpc.com/~sbd/CleanUp.html](http://www.execpc.com/~sbd/CleanUp.html)) and totally wipe the free space. This is a small utility that will easily fit on a floppy disk. Using this utility makes it almost impossible to recover data, it is much more effective than simply formatting a disk.

Deleting files from a network drive is pretty similar. Once you've deleted something go to *Start menu - Run* type **command.** then change to the drive that you have deleted from by typing the drive letter followed by a colon (e.g. **u:**) then type **cd/** and then type **purge \* /a** on most networks this will ensure that files are

completely deleted.

**Changing files.** This is pretty obvious really, rather than deleting files that could possibly be restored from backup, try changing files instead. Arguably the best thing to do is a search for spreadsheet files (\*.xls or \*.wk\*). Find them using the *Start menu - Find*. stick \*.xls, \*.wk\* in the *Named* box. Then sort them by modified date by clicking on the *modified* label, double click on the most recently modified file or one that looks like it may contain important financial information (big files are best). Then simply change the odd number here and there. It may be a long time before they realise the error, and will mean that they have to do a lot of checking throughout that file to look for other errors. They probably won't be able to restore from back-up as they may not know when the change occurred (it may not be discovered for months) and even if they know when the changes were made other parts of the spreadsheet may have been updated since then making a restore from backup impractical.

**Inserting a virus.** Before inserting a virus take a look at the properties of any running virus detection program. Next to the clock on the bottom right of the screen there will probably be some small icon indicating that an anti-virus program is running. Double click on it and take a look at the properties. What you have to try and do is to stop the anti-virus program from scanning files but not stop it running. Uncheck any boxes like *scan files on Run, copy* etc. You may be able to stop it from scanning (exclude) whole disk drives. Viruses that you have brought in will probably be detected so you want to stop the computer from scanning files but make it look like it is still running properly. If you can't do this then you may have to disable the virus protection. This may be discovered earlier.

## Macro viruses

If your virus is a Word virus then before you insert it you must disable Word's own virus protection. Open Word, open *Tools - options* and click on the *General* tab. Uncheck the *macro virus protection* box (do the same in Excel if your virus is in an .XLS file). Now try inserting your virus by either running the program or opening the document. If the virus protection on the machine finds it and you have the option to exclude this virus from the virus list then do so. If not then you will have to disable the anti-virus program. First look at the virus programs properties (as above) and stop it from loading on startup (if that option exists) next close down the icon near the clock in the bottom right of the screen. Then open Windows Explorer and check out what is in *C:\windows\start menu\programs\startup*. If there is an icon there that looks like it is an anti-virus program delete it. Next go to *Start menu - Run*. Type **sysedit**. Look at the win.ini file (within the sysedit box), right near the top of this file there should be two lines that start *Load= & Run=*, delete anything that looks like it is anti-virus related on these lines. Next look at the autoexec.bat file (again in the sysedit box) and again delete anything that looks virus related. Now close the sysedit window.
